CANCELLATION AND DELAY

If you request any alteration in the design, specification or quantity of the Goods we are entitled, should we choose to accept such alteration, to vary the price.

 We reserve the right by giving notice before delivery or supply to increase the price of the Goods to reflect any increase in cost to us. Prices quoted by us are exclusive of costs of delivery unless otherwise stated.

These terms will be clearly outlined in the credit agreement and may include various customer terms agreed upon. Customers are required to adhere to these terms for timely payment of invoices.
 6.1.3 For customers with agreed 50:50 payment terms, 50% payment is required on confirmation of order and the remaining 50% payable 10 days prior to despatch. The initial payment received on order confirmation is non-refundable once the order is confirmed and production has commenced.
